GRYR 8008-D supersedes and replaces in its entirety the prior published versions.

Containing local rates and freight charges applying from, to, between and at stations on the Grenada Railroad, LLC.

This Tariff applies only to freight traffic.

Any services not covered by the charges in this tariff document are subject to the rules and provisions of the Freight Tariff Pinsly 8100-series, as may be amended, supplemented, modified or superseded from time to time.

Any claim for loss or damage to any one shipment transported shall be filed with the Line Haul Carrier interchanging the shipment destined to or originating from the GRYR.

#### ITEM 1005 INTERMEDIATE SWITCH CHARGE AT MEMPHIS, TN

#### (PREVIOUSLY PUBLISHED AS ITEM 360):

The GRYR has a direct interchange with the Canadian National Railroad (CN) at Memphis, TN. GRYR is also able to interchange with BNSF, CSXT, NS, and UP at Memphis, TN via CN Intermediate Switch service.

Unless otherwise noted in a private agreement, rail rates provided by the GRYR will not include absorption of the CN Intermediate Switch charges on railcar movements between GRYR and BNSF, CSXT, NS, and UP.

Payment of unabsorbed Intermediate Switch charges will be the responsibility of the Customer and invoiced by GRYR accordingly to their account.

The GRYR charge to administrate this service for interchange to or from Memphis, TN is \$630 per car ("ISC"). Published charges are subject to change with 20-day notification.

#### Application of the ISC for Freight Shipments:

- ISC is chargeable on car movements involving GRYR connecting carriers BNSF, CSXT, NS, UP
- ISC is applicable for loaded and empty movements in both directions
  - Inbound empty car to GRYR with subsequent outbound loaded shipment
  - Inbound loaded car shipment to GRYR with subsequent outbound empty return
- ISC will be invoiced as a separate line item on the freight invoice

#### Application of the ISC for Railcar Storage Shipments:

- ISC is chargeable on car movements involving GRYR connecting carriers BNSF, CSXT, NS, UP
- ISC is applicable depending on GRYR Class 1 interchange partner on inbound/outbound move segment
